Concerned you might not have enough to provide a Legacy Gift?

Sometimes, people are unsure whether they will have enough to provide for their loved ones and create a legacy gift for the future. If this is a concern for you, there's a way to make sure your loved ones receive what you intend and to fulfil your charitable wishes.

A residual gift can be made from what is left of your estate after all debts and specific gifts to loved ones have been paid, and it may be the best option for you. A charitable tax receipt for the full amount of your gift will be issued which can be beneficial to your loved ones when applied to the tax filings of your estate.
